Tournament Description

Final sanction approval depends on the extent to which safety is being addressed. This information will be forwarded to the USA Water Ski rated safety official listed above, who will be responsible for assuring that all potential risks are managed properly. **Ramp jumping will not be approved unless it is sanctioned as a "Class N" or above tournament.**

The Organizing Club Hereby Represents, Certifies and Agrees that:

1. No competitor shall be permitted to ski in the tournament unless his/her USA Water Ski "Active" membership dues are paid in full. A foreign skier may ski if he is a member of an IWSF-affiliated Federation and can provide proof of USA Water Ski insurance coverage. Guest memberships may be purchased for \$10 per event. **Guest members may not jump over a ramp.**
2. The Organizing Club shall provide the site, equipment and the personnel required for the tournament.
3. The tournament shall be operated in strict conformity with USA Water Ski policies and safety procedures.
4. All USA Water Ski membership registration forms shall be properly documented and forwarded to USA Water Ski's Competition Department with all membership fees collected immediately following the tournament.
5. The undersigned is authorized to make these agreements on behalf of the Organizing Club.
