- 3. The tournament shall be operated in strict conformity with the Official Tournament Rules and USA Water Ski policies and safety procedures.
- 4. All USA Water Ski membership registration forms shall be properly documented and forwarded to USA Water Ski's Competition Department with all membership fees collected.
- 5. The tournament shall be officiated exclusively by USA Water Ski-rated or IWSF-affiliated judges, drivers, scorers, safety directors and technical controllers/homologators.
