Masters / Ranking List level 7 rated skiers may complete only those blanks on this application indicated with an asterisk (*) for each event in which a Masters / Ranking List level 7 rating is held. A copy of a signed Masters / Ranking List level 7 rating must be included with this application. All applicants must complete the "General" section.  Maintenance Requirements for Judges are based biennially; i.e., work performed 1/1/05 – 12/31/06 counts for renewal for 2007.  Attention Chief Judges: Please be discriminating.
